Registration Fee: \$100.00 per child. This fee reserves a spot for your child, is non-refundable and will go towards camp tuition.

ENROLLMENT TERMS

- 1. **Registration Fee:** The registration fee is due with application and saves a spot for your child. The registration fee is NON-REFUNDABLE and the amount is applied towards camp tuition.
- 2. **All Season Discount:** Campers that register for the four sessions (All Season) receive a 5% tuition discount. All Season must be paid in full by May 31, 2024.
- 3. **Early Bird Special:** Campers that register by April 1, 2024 receive an early bird discount, in addition to other discounts such as sibling or All Season.
- 4. Late Registration: all registrations received after May 15, 2024 are subject to the Late Registration rate.
- 5. **Schedule Changes:** All changes made to the original registration after May 15, 2024 are subject to a \$50 administrative fee per change per child.
- 6. **Sibling Discount:** If two or more children from the same family are enrolled concurrently, the second and subsequent siblings will receive a discount of 5% on the lesser tuition.

Note: Early Bird and sibling discounts **do not apply** to Registration Fee or Occasional Care.

- 7. **Camp fees:** Camp fees are due in full by the first day of each month or the Friday before. Sessions 1 and 2 are due on May 31st. Sessions 3 and 4 are due on July 1st. All Season fees are due on May 31st, 2024. Late fees will be subject to a \$25.00 late fee after the first of the month. Insufficient funded checks will have a \$50.00 fee.
- 8. Late Pickup Fee: A late fee of \$13 for every hour or part of an hour will be applied if children are picked up later than their scheduled time. All late pickups after 5:00 p.m. will incur a late fee of \$13.00 for every 5 minutes.
- 9. **Absences:** No refunds will be given for absences for any reason.
- 10. **Cancellation:** Cancellation of services must be in writing and sent to our office two weeks before the start of the cancelled session. A cancellation fee of 30% of any unused tuition will be assessed.
- 11. **Payment:** All payments can be made by check, credit card, or ACH transfer.
- 12. **Eligibility:** To be eligible for our Muddy Boots Camp, a child must be 36 months of age and able to use the bathroom independently. To qualify for our Nature Explorers Camp a child must have completed kindergarten.
- 13. **T-Shirt:** One camp T-Shirt per child is included with registration, regardless of how many sessions the child attends.
- 14. **Termination:** Nature Walk Montessori School reserves the right to terminate this contract at any time if it determines, in its sole discretion, that:
 - the camper is unable to thrive in the school's environment
 - the school is unable to meet the camper's needs
 - the attitude or conduct of the camper or of the parents is not compatible with the school's mission or with the welfare of the other students
 - A. If the school terminates this contract under these circumstances, the undersigned shall thereafter be excused from further tuition responsibility
 - B. The school is limited to a refund of the unearned portion paid in advance of services.
